




Fig. 4.1 Definitions of Electrical Characteristics






Fig. 7.1 Land Pattern Dimensions (Unit: mm)







Fig. 8.1 I-V








Fig. 9.1 V_C - I_{PP}





Fig. 11.3 IEC61000-4-2 (Contact)
