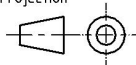

F Typical Impedance Characteristics:



Common Mode

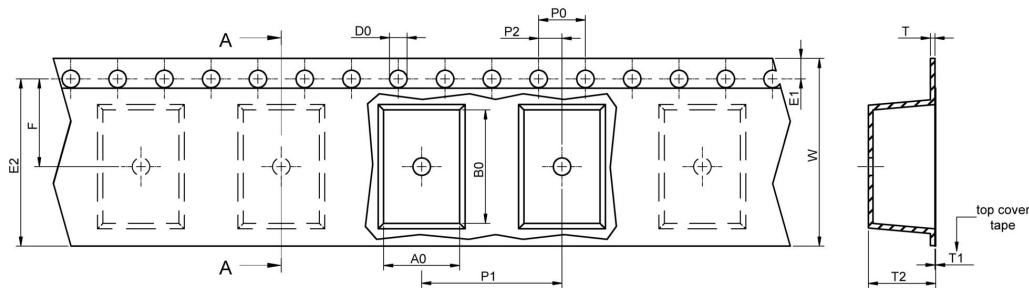


Differential Mode

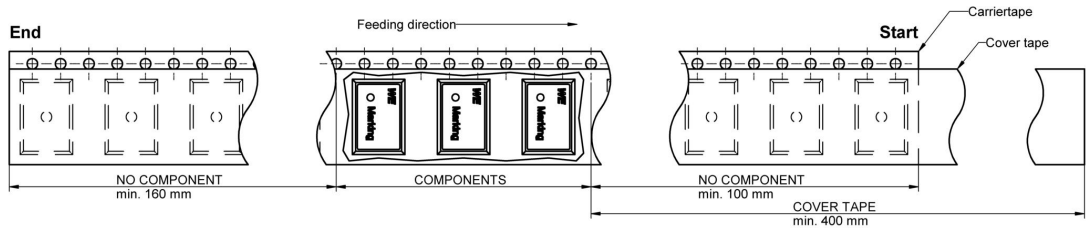
