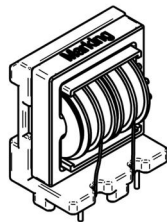

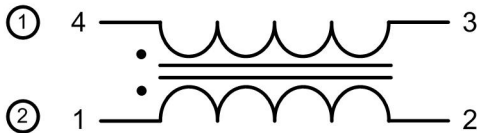

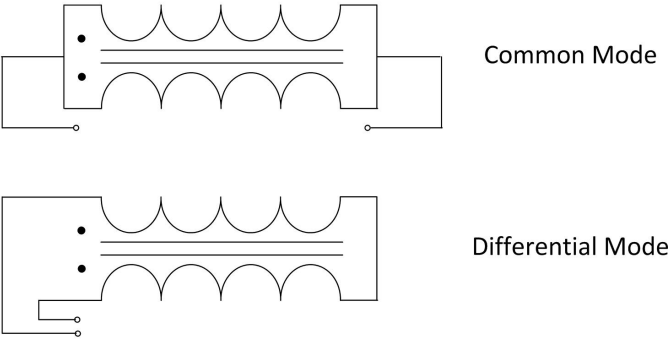



H4: Classification Wave Soldering Profile:



### Product specific:
