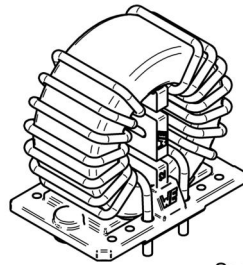
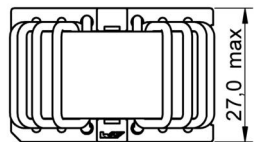
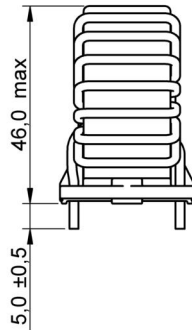
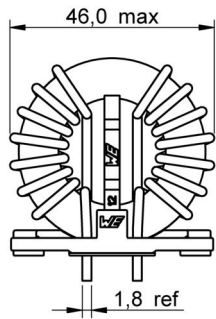
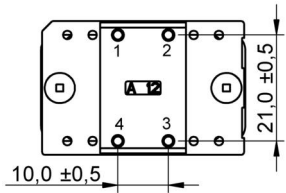
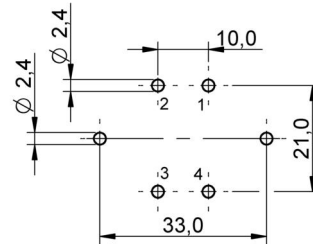

- Violation of the technical product specifications such as exceeding the nominal rated current will void the warranty.
