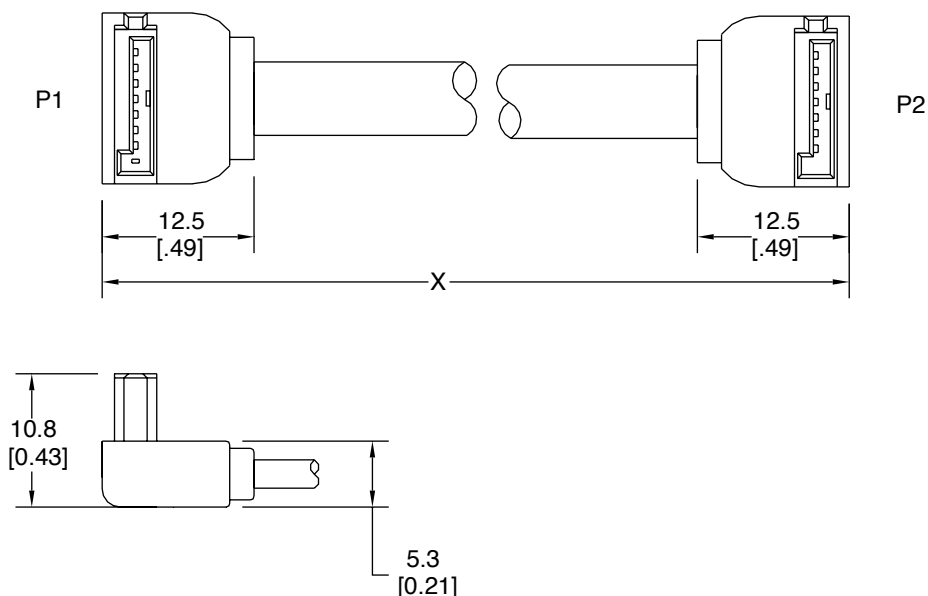

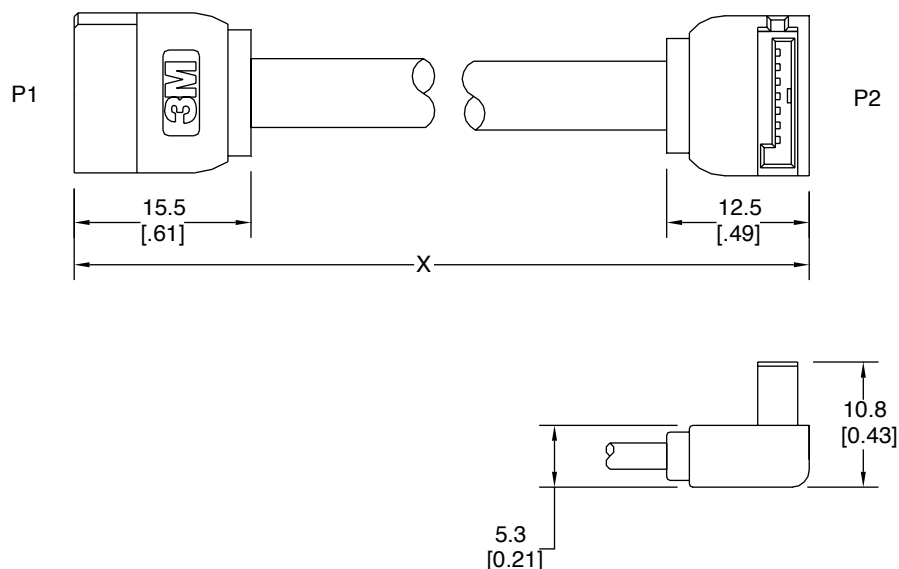

Straight to Right Angle



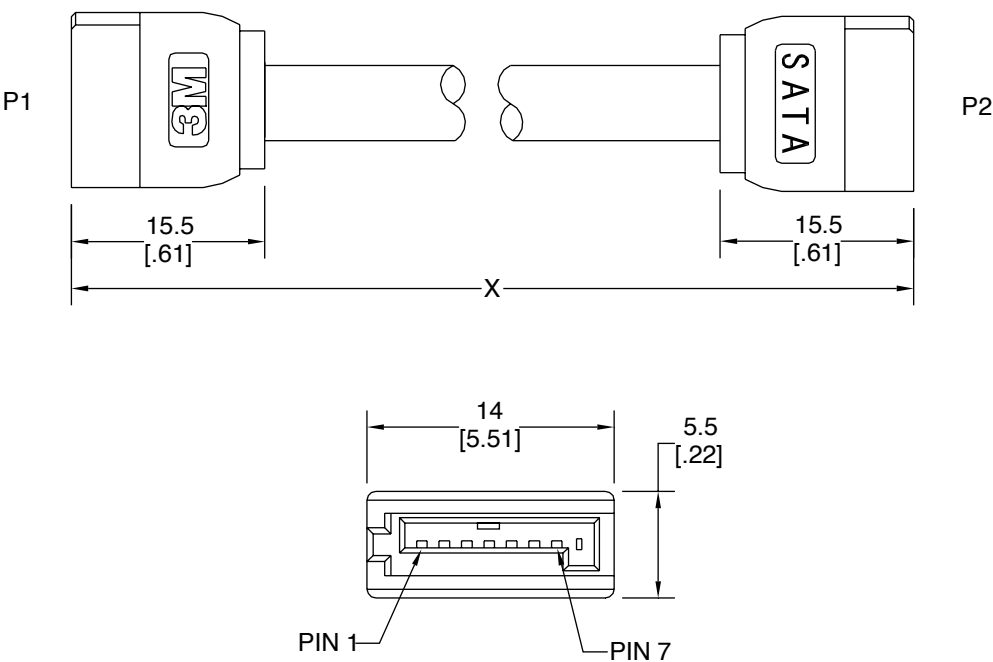
