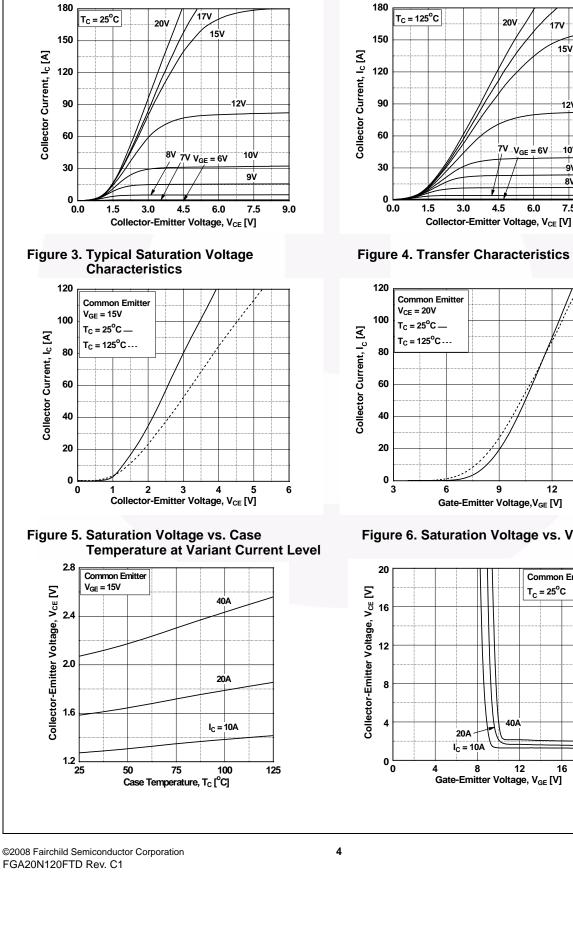




Figure 6. Saturation Voltage vs. V_{GE}




Figure 2. Typical Output Characteristics

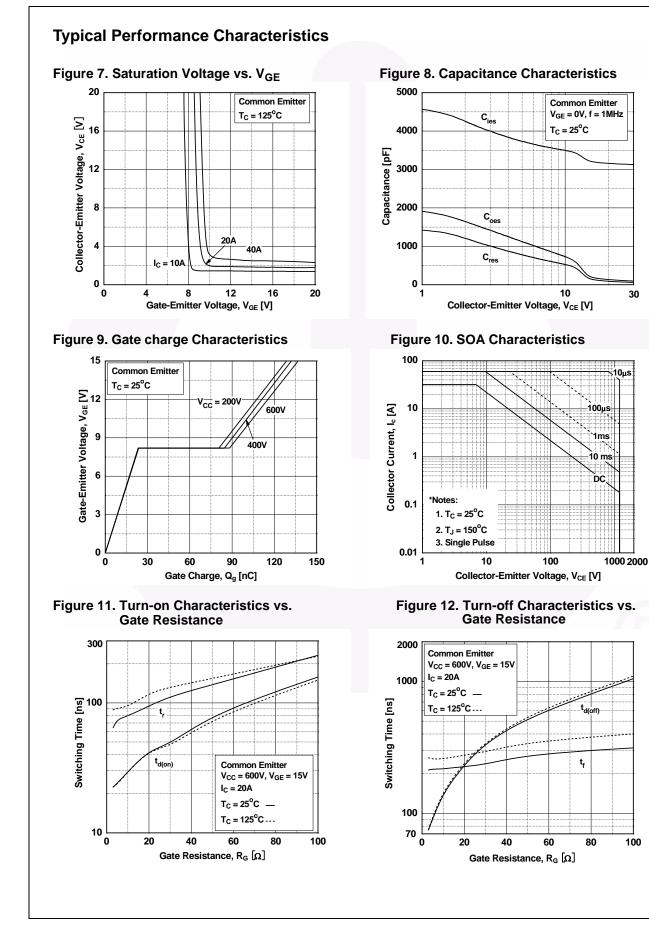

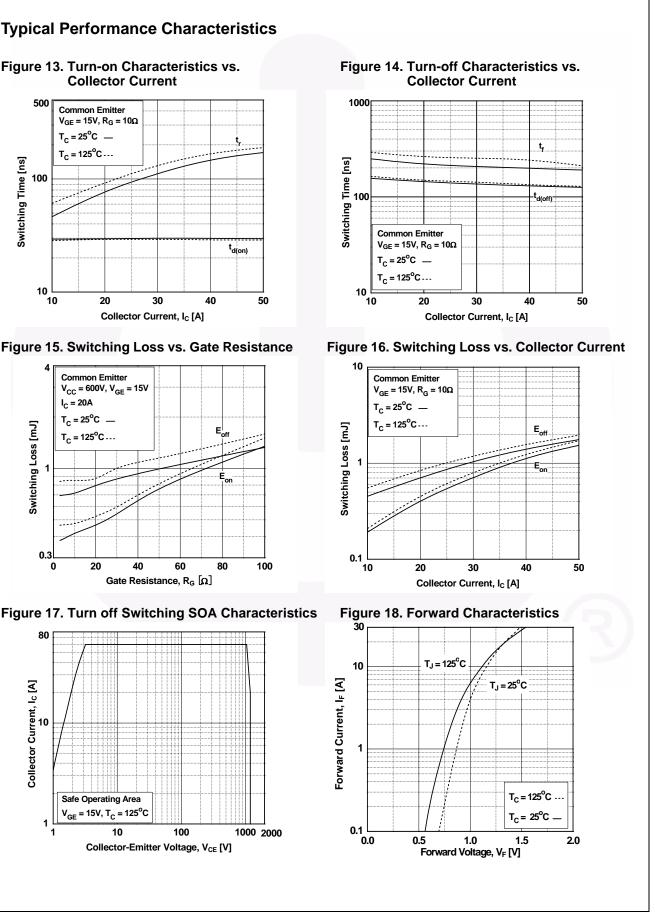


Figure 15. Switching Loss vs. Gate Resistance
