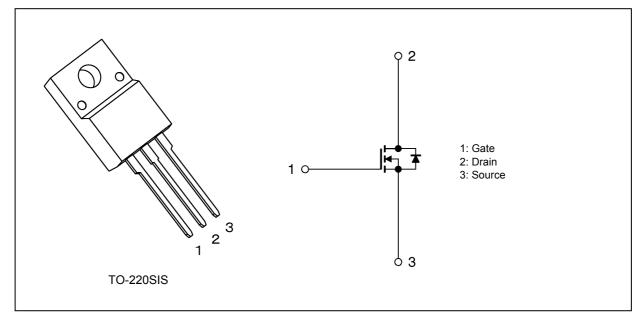






Fig. 7.1 Marking



Total gate charge Q_g (nC) Fig. 8.10 Dynamic Input/Output Characteristics





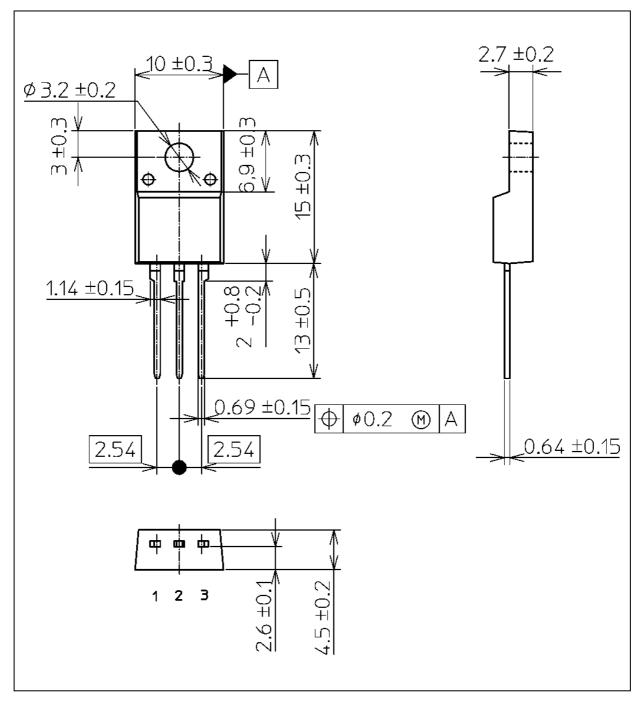
