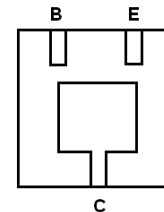
Top View

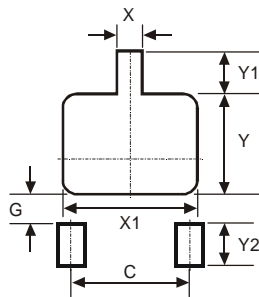
