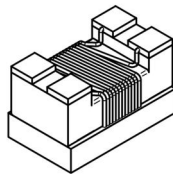

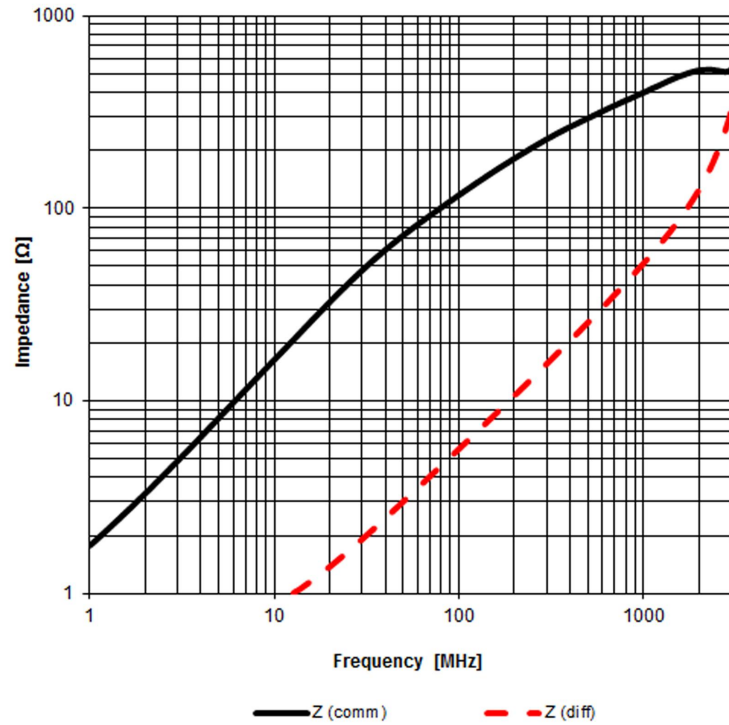

Common Mode



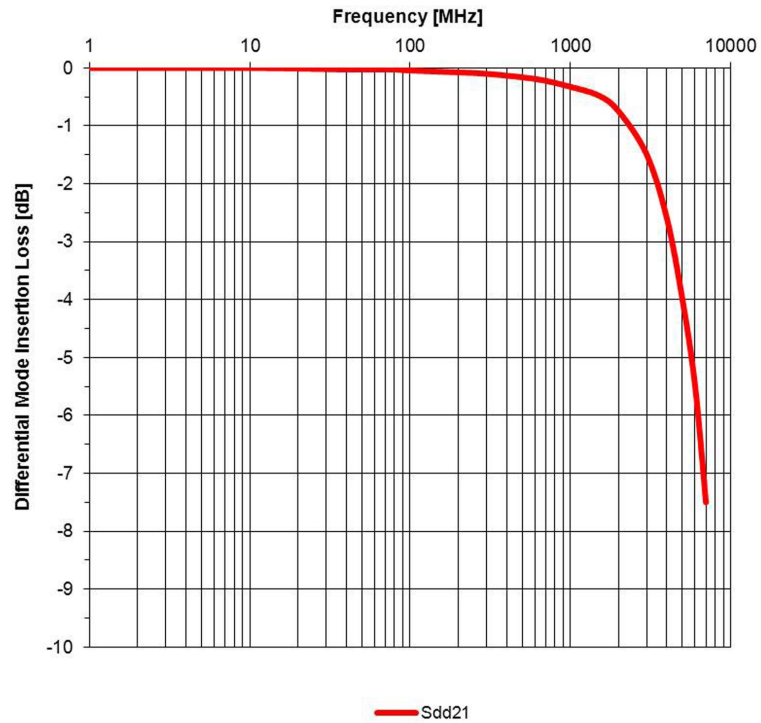
