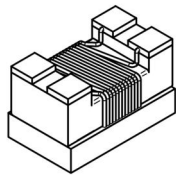

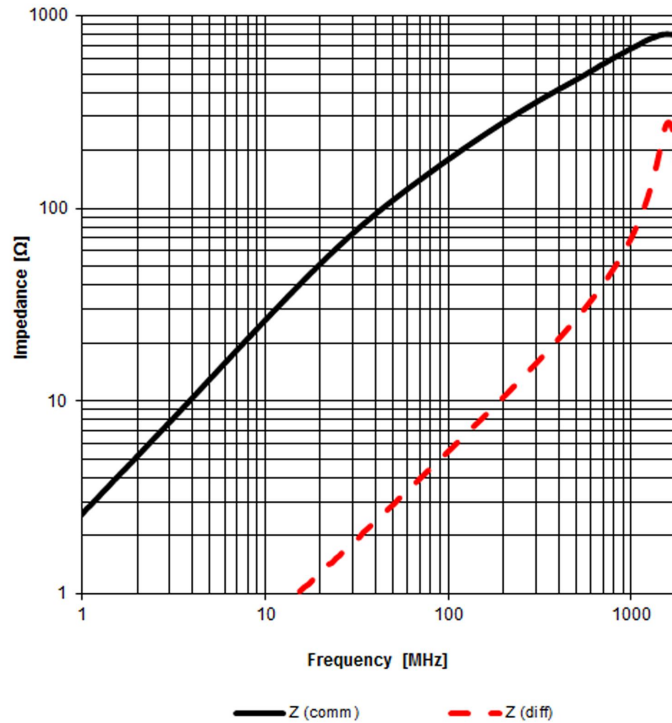

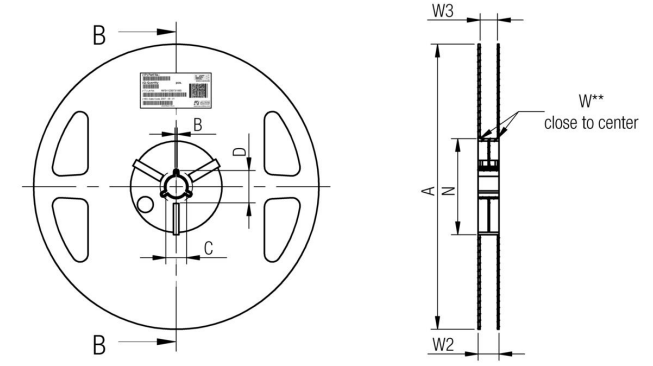


Differential Mode

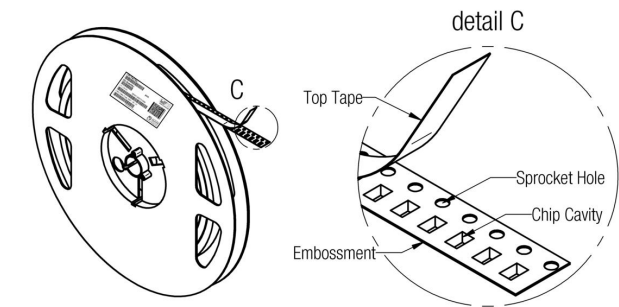
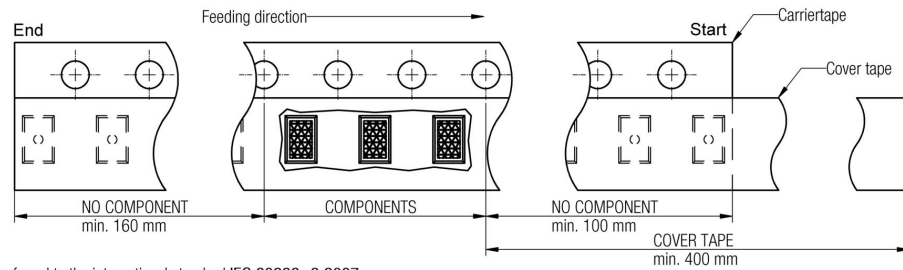

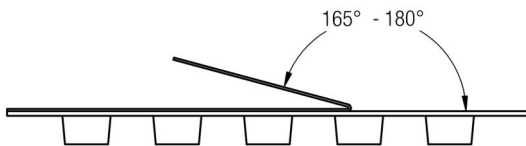
