

B Recommended land pattern: [mm]

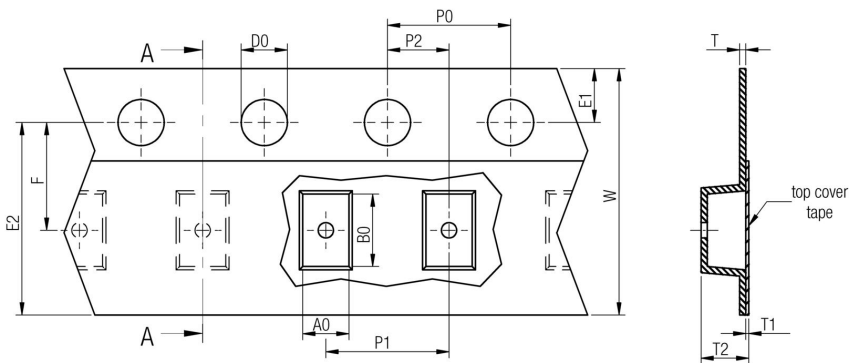
F Typical Differential Mode Insertion Loss Characteristics:



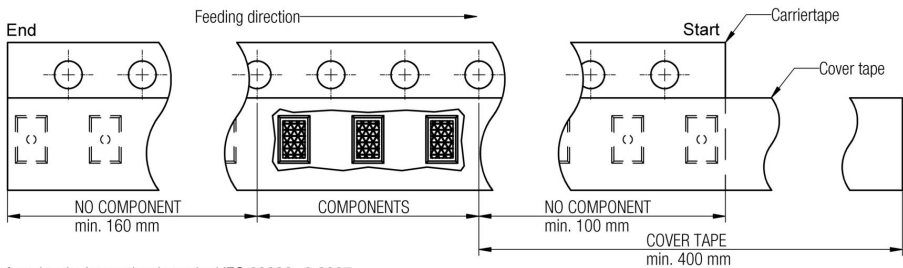
