




F1 Viewing Angle:

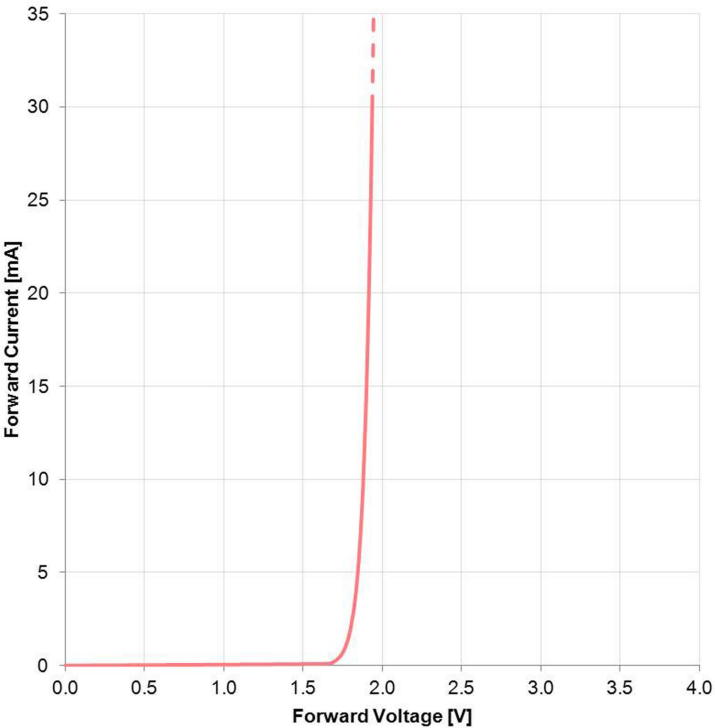

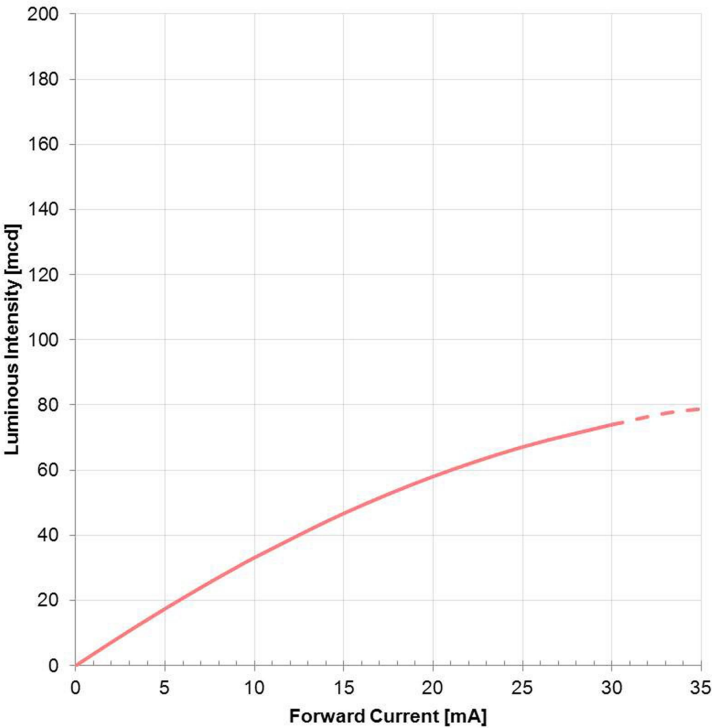

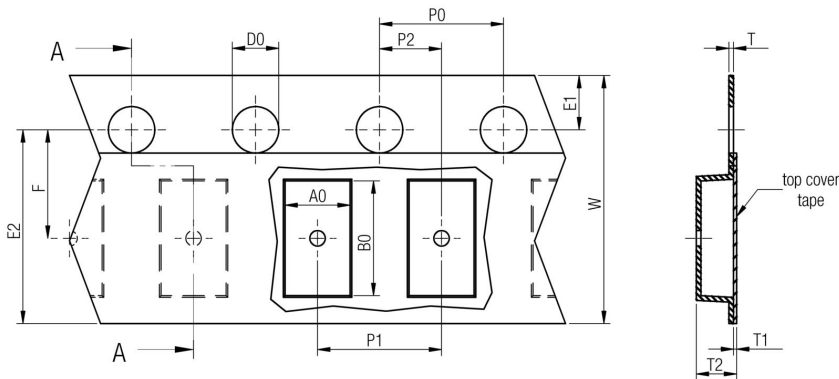
F5 Derating Curve:



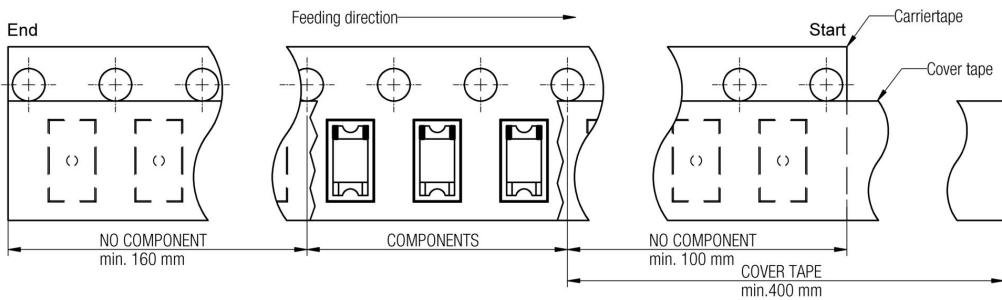

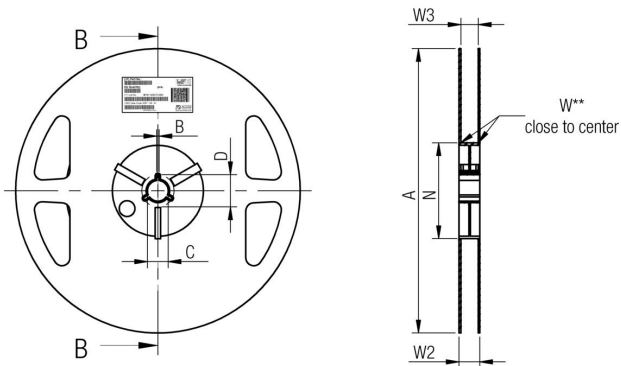

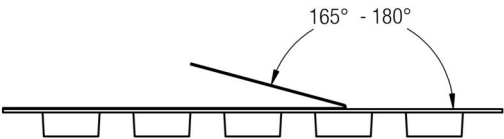
