Typical Insertion Loss:



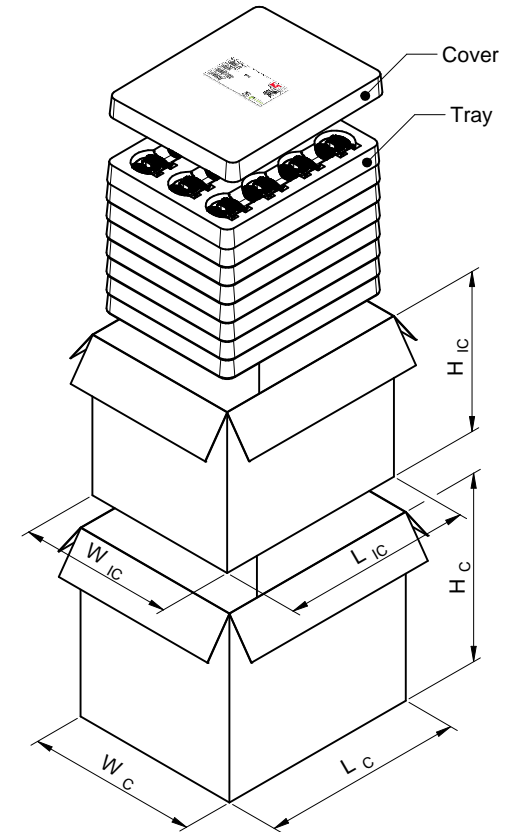
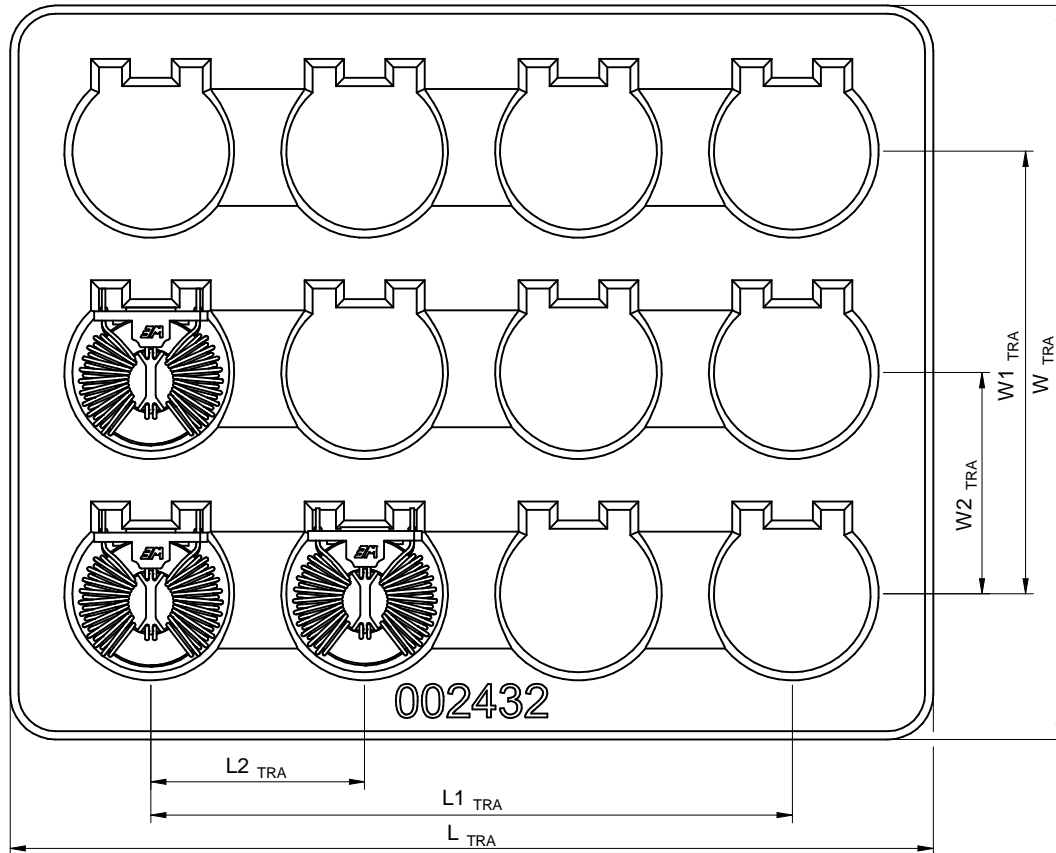
