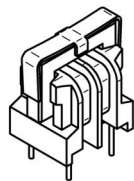

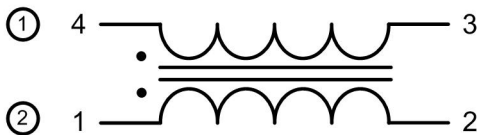
B Recommended hole pattern: [mm]

C Schematic:

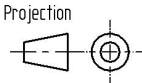

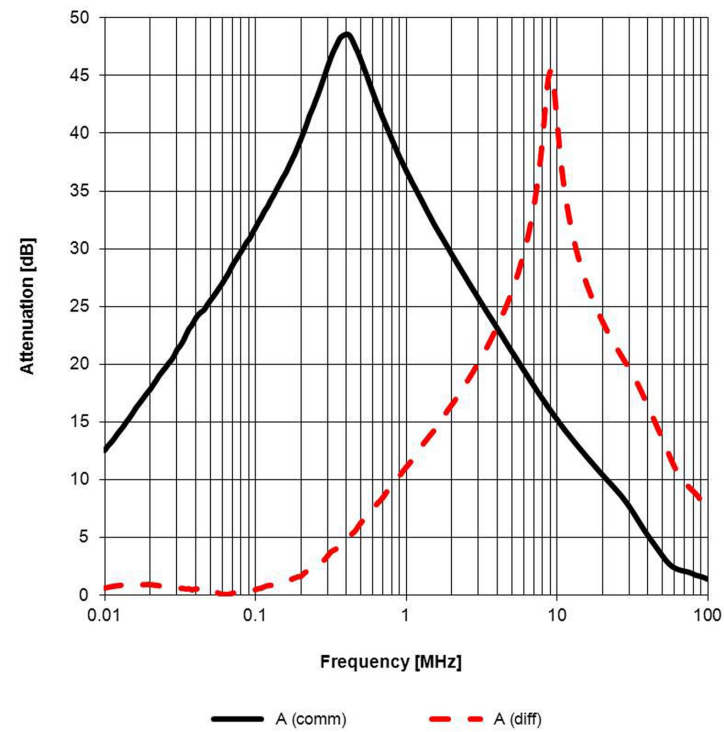



F Typical Insertion Loss Characteristics:
