









Figure 3. Normalized Radiant Intensity vs. Forward Current Normalized to: IF = 100mA Pulsed Ie - NORMALIZED RADIANT INTENSITY tpw = 20ms Duty Cycle = 4% $T_A = 25^{\circ}C$ 0.1 10 1000 I_F - FORWARD CURRENT (mA)








Typical Performance Curves (Continued)
