







Figure 1. Normalized Radiant Intensity vs. Forward Current

Figure 2. Forward Voltage vs. Ambient Temperature






Figure 3. Normalized Radiant Intensity vs. Wavelength




Figure 5. Forward Current vs. Forward Voltage
