






## •Electrical characteristic curves(T<sub>a</sub>=25°C) <For Diode>






## Electrical characteristic curves(T<sub>a</sub>=25°C) <For Transistor>






## •Electrical characteristic curves(Ta=25°C) <For Transistor>






## •Electrical characteristic curves(Ta=25°C) <For Transistor>
