

Average Operating Times at 20 °C Related to Multiples of the Setting Current




- 1 3 poles from cold state



Thermal Limit in kA²s in the Magnetic Operating Zone









Mounting of External Operator GVAPH02 for Motor Circuit Breakers GV2P




