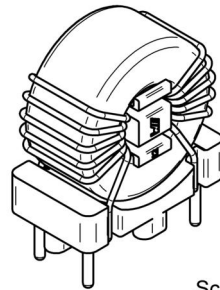

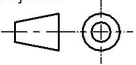

### Product specific:


