Schematic:



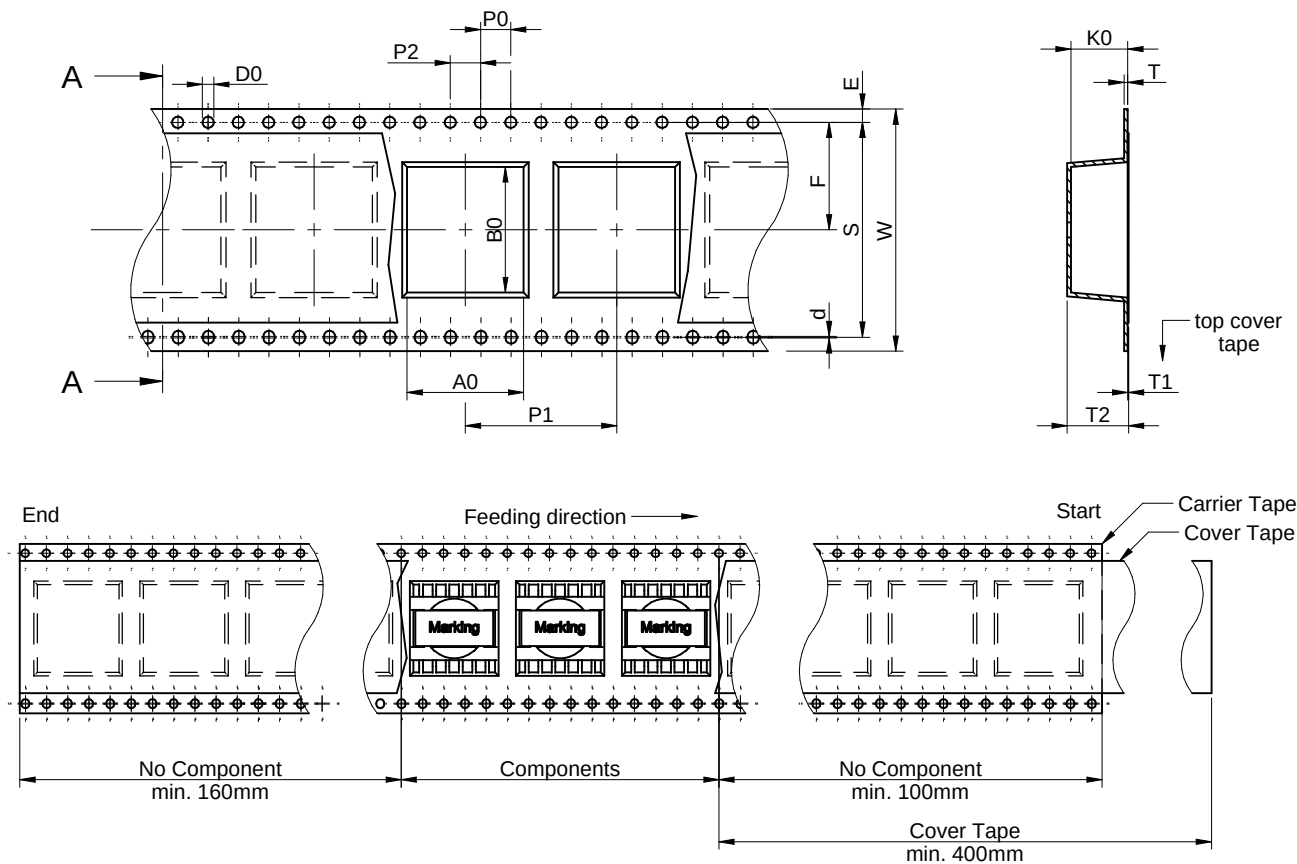
