










Fig.4 DC current gain vs. collector current (II)









## Fig.5 Collector-emitter saturation voltage vs. collector current (I)







# Fig.7 Base-emitter saturation voltage vs. collector current

## • Electrical characteristic curves ( $T_a = 25^{\circ}C$ )








Fig.10 Safe Operating Area


