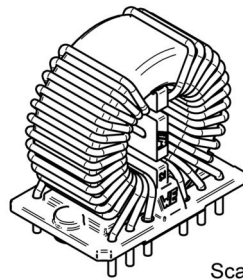

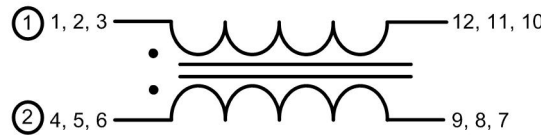

C Schematic:



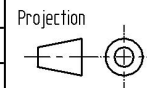

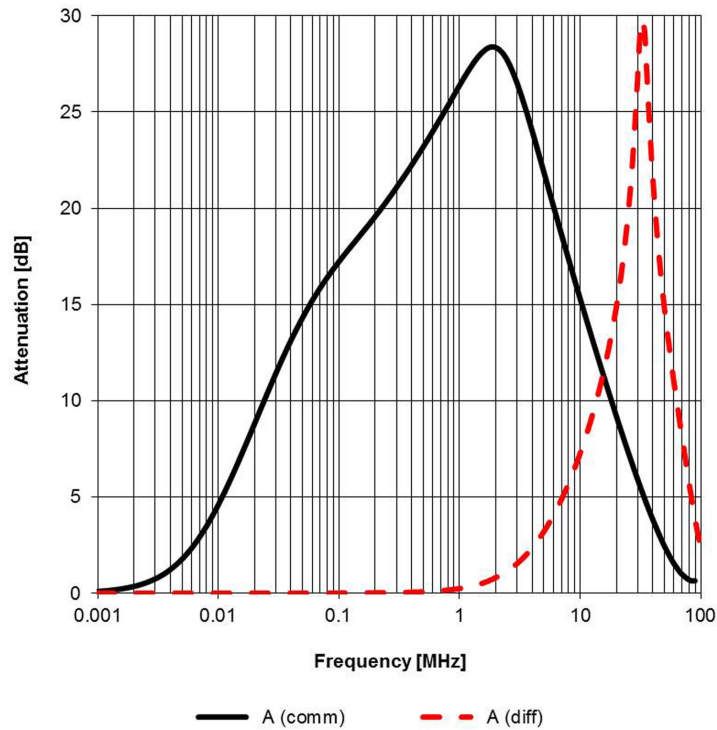



Product specific:
