






Fig. 7.1 Marking






Fig. 8.6 R_{DS(ON)} - I_D





Fig. 8.7 R_{DS(ON)} - T_a



Drain-source voltage V_{DS} (V) **Fig. 8.9 C - V**_{DS}




Fig. 8.11 V_{th} - T_a




Fig. 8.8 I_{DR} - V_{DS}




Fig. 8.10 Eoss - V_{DS}




Fig. 8.12 Dynamic Input/Output Characteristics




Fig. 8.13 r_{th} - t_w (Guaranteed Maximum)




Fig. 8.14 E_{AS} - T_{ch} (Guaranteed Maximum)




Fig. 8.15 P_D - T_c (Guaranteed Maximum)




Fig. 8.16 Test Circuit/Waveform





Fig. 8.17 Safe Operating Area (Guaranteed Maximum)
