Typical Impedance Characteristics:



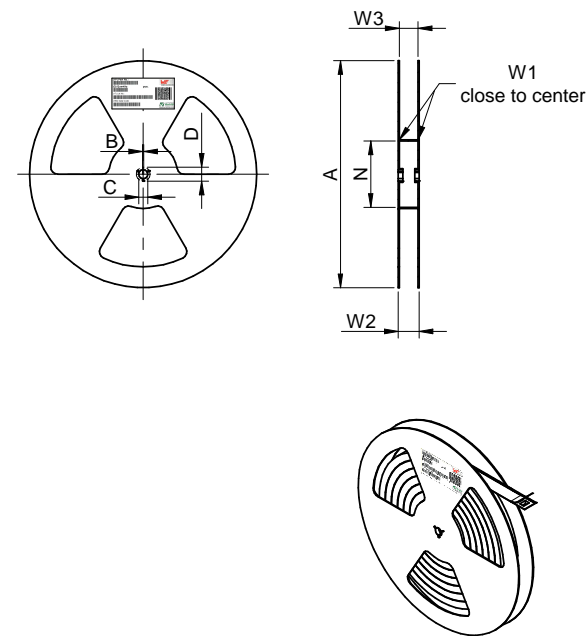
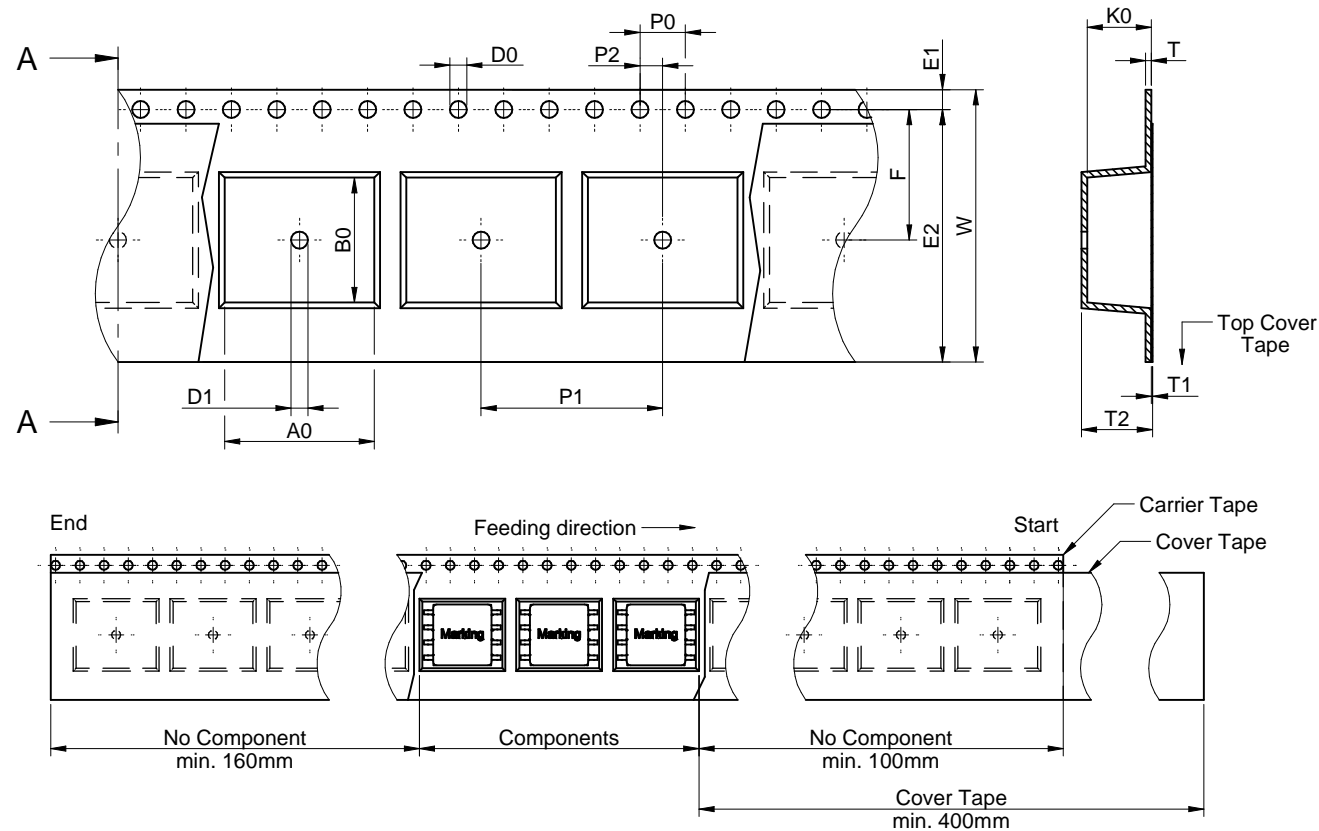
