


Figure 1. MMBTA56 Device Package




Figure 2. PZTA56 Device Package




Figure 3. Typical Pulsed Current Gain vs. Collector Current




Figure 4. Collector-Emitter Saturation Voltage vs.
Collector Current




Figure 5. Base-Emitter Saturation Voltage vs.
Collector Current




Figure 6. Base-Emitter On Voltage vs.
Collector Current




Figure 7. Collector Cut-Off Current vs.
Ambient Temperature




Figure 8. Input and Output Capacitance vs. Reverse Voltage




Figure 9. Collector Saturation Region




Figure 10. Gain Bandwidth Product vs. Collector Current





Figure 11. Power Dissipation vs.




Figure 12. 3-LEAD, SOT23, JEDEC TO-236, LOW PROFILE
