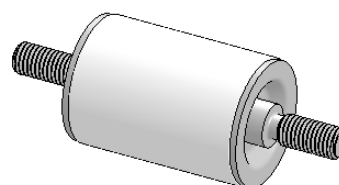
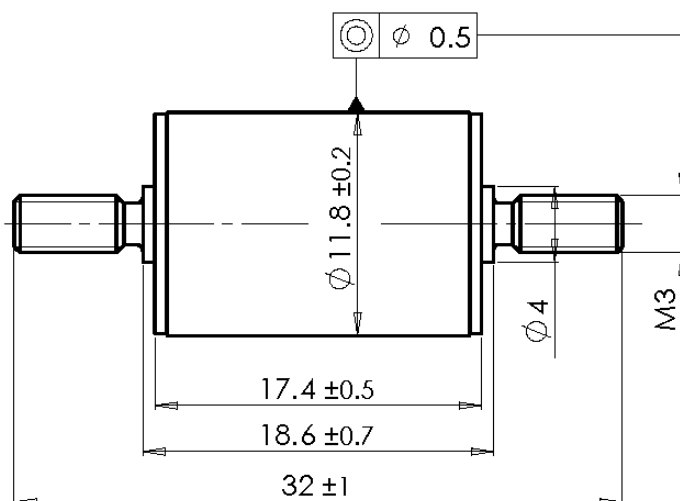

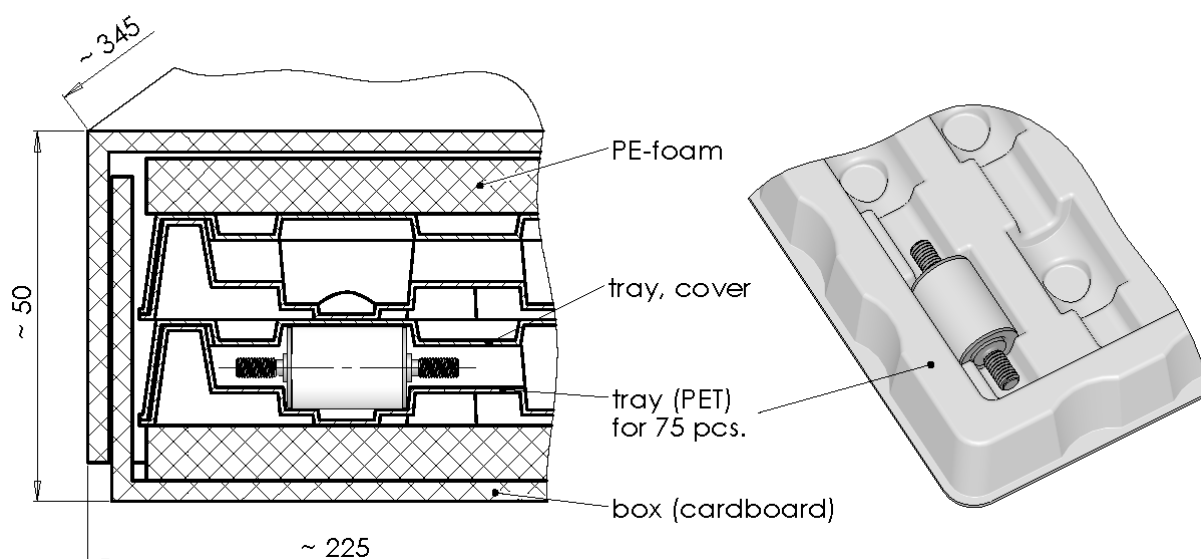

Cautions and warnings
