




Fig. 4.1 Definitions of Electrical Characteristics




Fig. 6.1 Marking




Fig. 7.1 Land Pattern Dimensions (Unit: mm)







Fig. 8.1 I - V



# 9. Clamp Voltage V<sub>C</sub> - Peak Pulse Current (I<sub>PP</sub>) (Note)








Fig. 9.1 V<sub>C</sub> - I<sub>PP</sub>





Fig. 11.3 IEC61000-4-2 (Contact)
