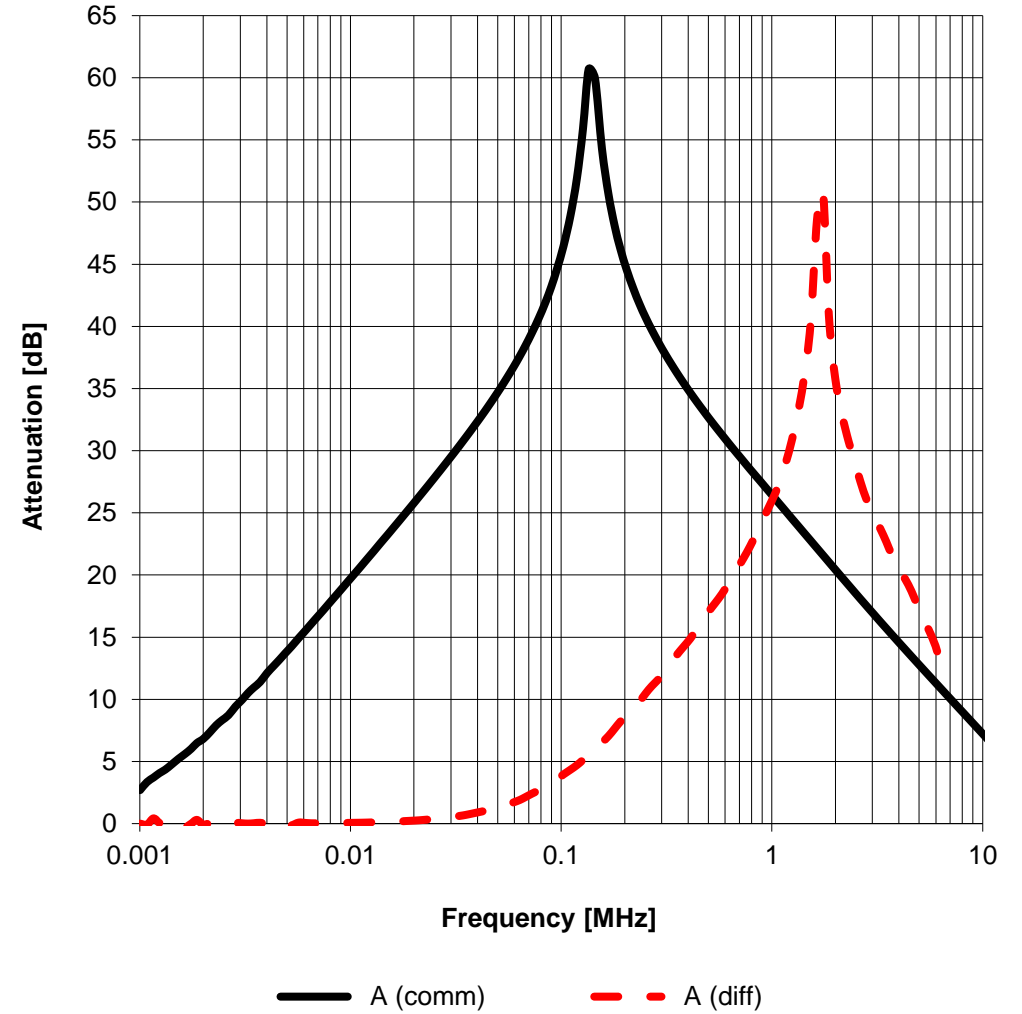
Common Mode




