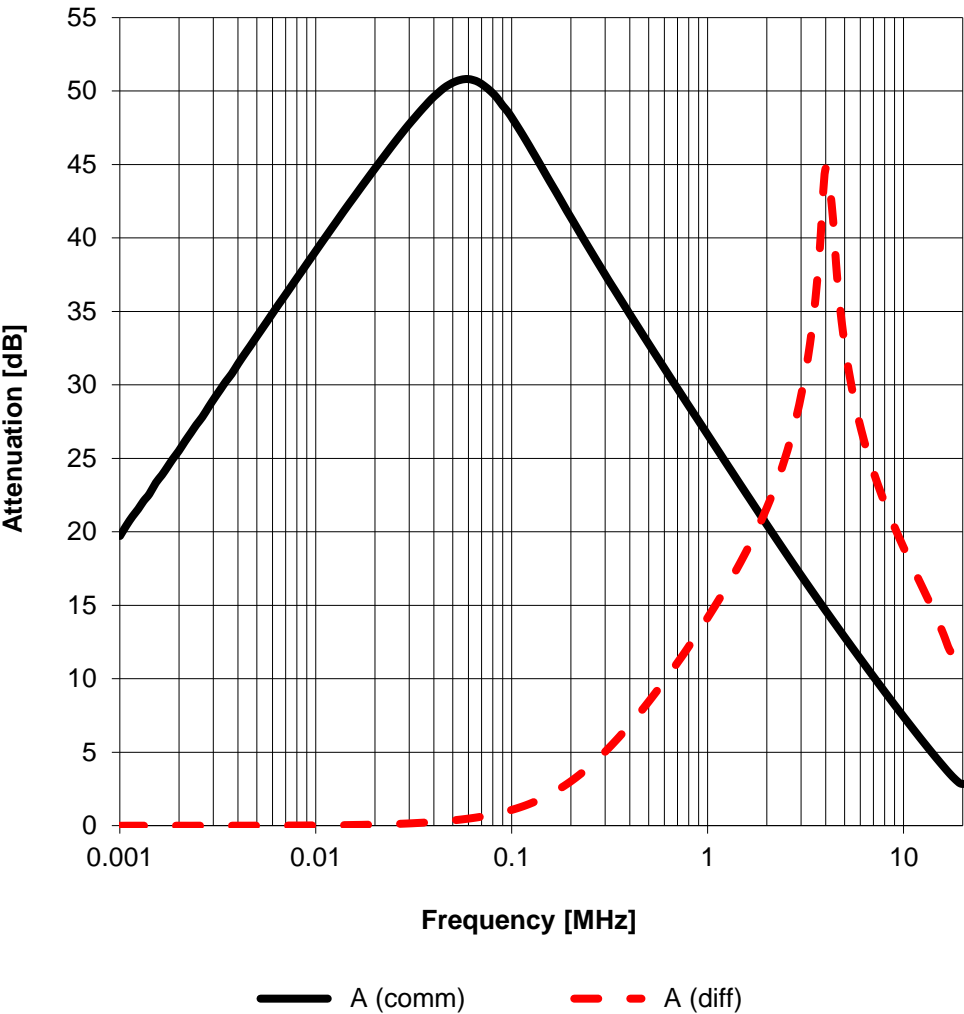





Differential Mode






