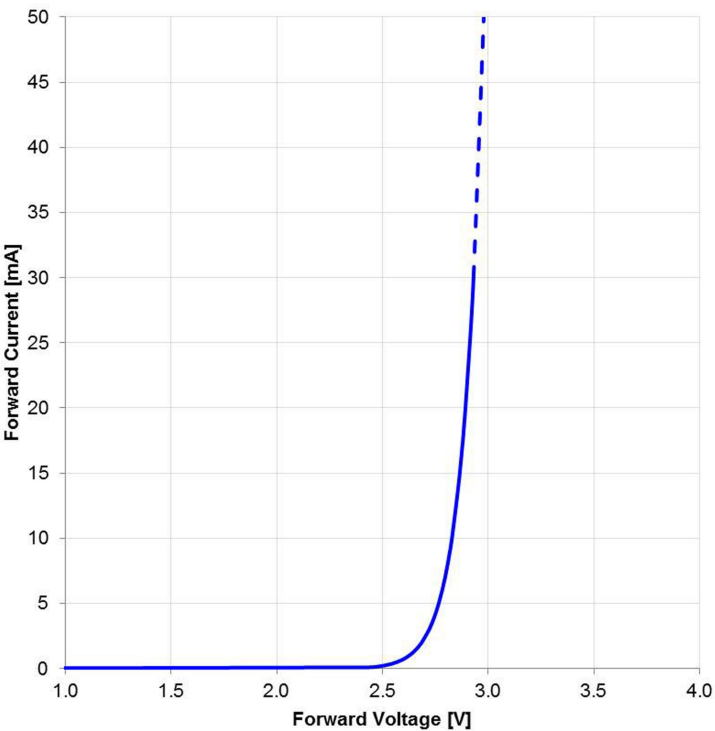






F3 Forward Current vs. Forward Voltage:



F4 Luminous Intensity vs. Forward Current:





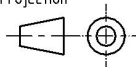

General:

All recommendations according to the general technical specifications of the data sheet have to be complied with.

If the product is potted in customer applications, the potting material might shrink during and after hardening. The bin is defined on intensity, chromaticity coordinate or wavelength and forward voltage. In order to ensure highest availability, the reel binning of standard deliveries can vary. A single bin cannot be ordered. Please contact us in advance, if you need a particular bin sorting before placing your order to clarify the lead time, MOQ and pricing.



Product specific:

Follow all instructions mentioned in the data sheet, especially:

- The soldering profile has to be complied with according to the technical reflow/ or wave soldering specification, otherwise this will void the warranty.
- All products shall be used before the end of the period of 12 months based on the product date code, if not a 100% solderability can't be ensured.
