General:

- The customer is responsible for the functionality of their own products. All technical specifications for standard products also apply to customer specific products.

Product specific:

Soldering:

- The solder profile must comply with the Würth Elektronik technical soldering specification. All other profiles will void the warranty.
- · All other soldering methods are at the customer's own risk.

Cleaning and Washing:

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the LED body, marking or plating. Washing agents may have a negative effect on the long-term functionality of the product.
- Using a brush during the cleaning process could break the LED body. Therefore, we do not recommend using a brush during the PCB cleaning process.

Potting:

If the product is potted in the costumer application, the potting material might shrink or expand during and after hardening. Shrinking
could lead to an incomplete seal, allowing contaminants into the LED body, pins or termination. Expansion could damage the LED body,
pins or termination. We recommend a manual inspection after potting to avoid these effects.

Storage Conditions:

- A storage of Würth Elektronik products for longer than 12 months is not recommended. Within other effects, the terminals may suffer
 degradation, resulting in bad solderability. Therefore, all products shall be used within the period of 12 months based on the day of
 shipment.
- Do not expose the components to direct sunlight.
- The storage conditions in the original packaging are defined according to DIN EN 61760-2.
- If there is a moisture sensitive component, the storage condition in the original packaging is defined according to IPC/JEDEC-J-STD-033. It is also recommended to return the component to the original moisture proof bag and reseal the moisture proof bag again.

Handling:

- Violation of the technical product specifications such as exceeding the nominal rated current, will void the warranty.
- Product design might influence the automatic optical inspection.
- Certain LED surfaces consist of soft material. Pressure on the top surface has to be handled carefully to prevent negative influence to
 the function and reliability of the LEDs.
- ESD prevention methods need to be applied for manual handling and processing by machinery.
- Resistors for protection are obligatory.
- Luminaires in operation could harm human vision or skin on a photo-biological level, therefore direct light impact shall be avoided. All
