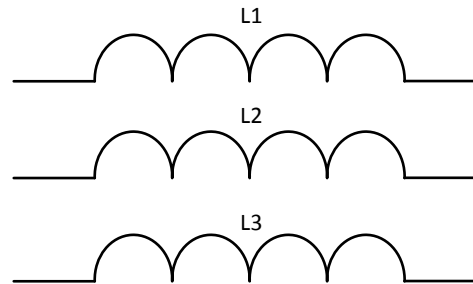

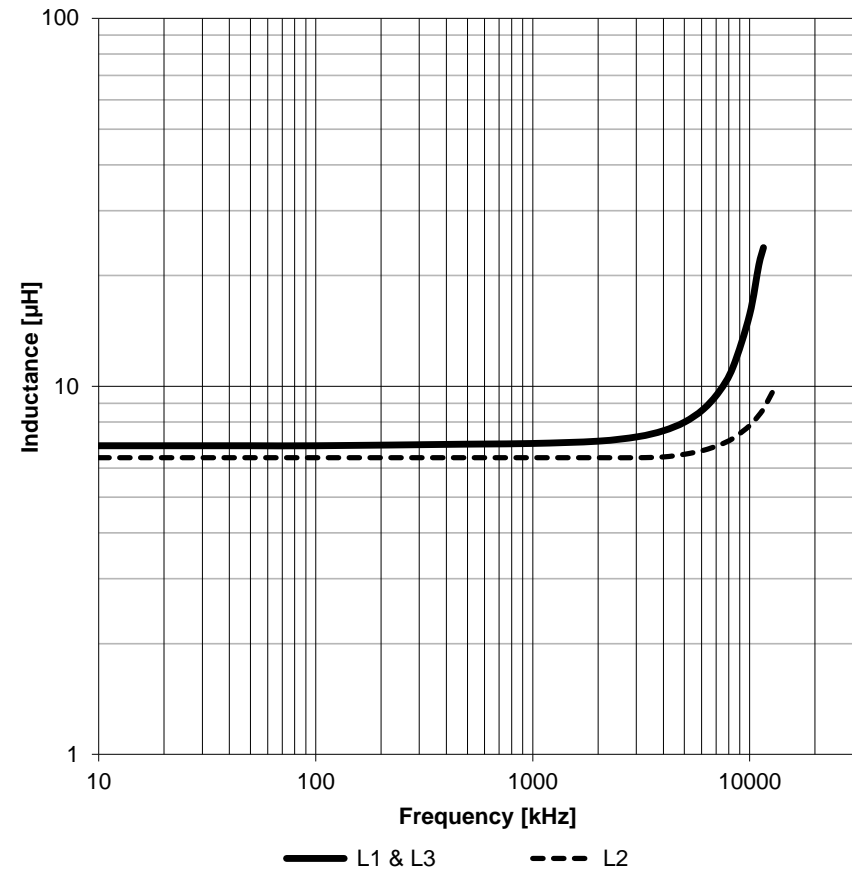

Typical Inductance vs. Current Characteristics:



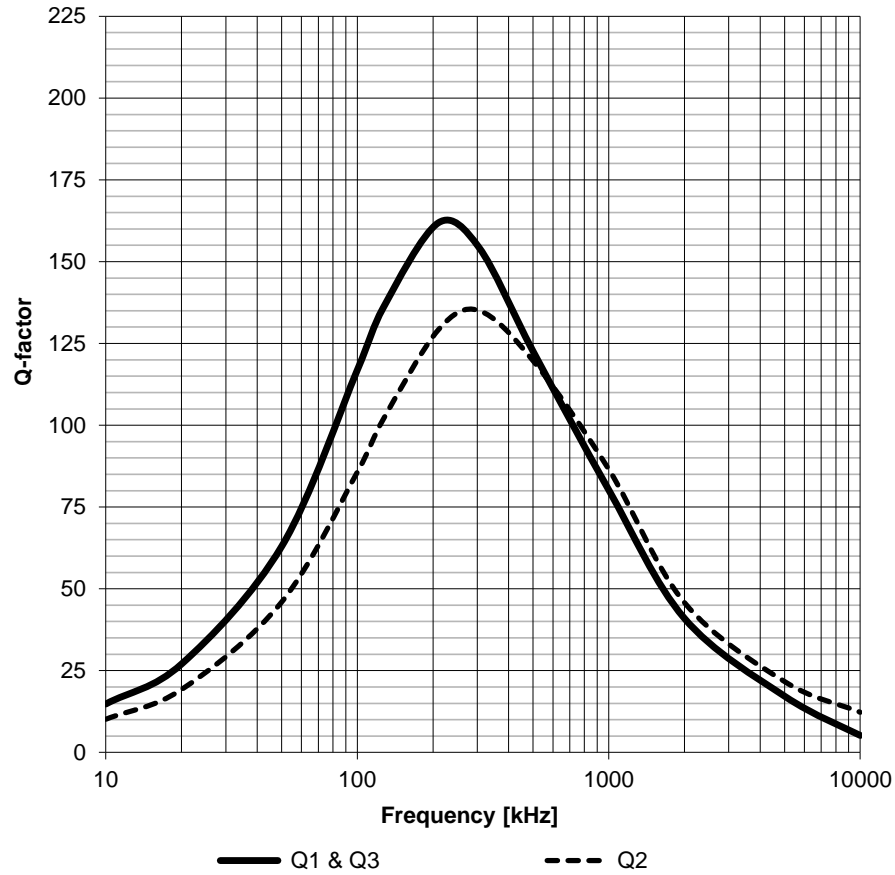
Typical Inductance vs. Frequency Characteristics:



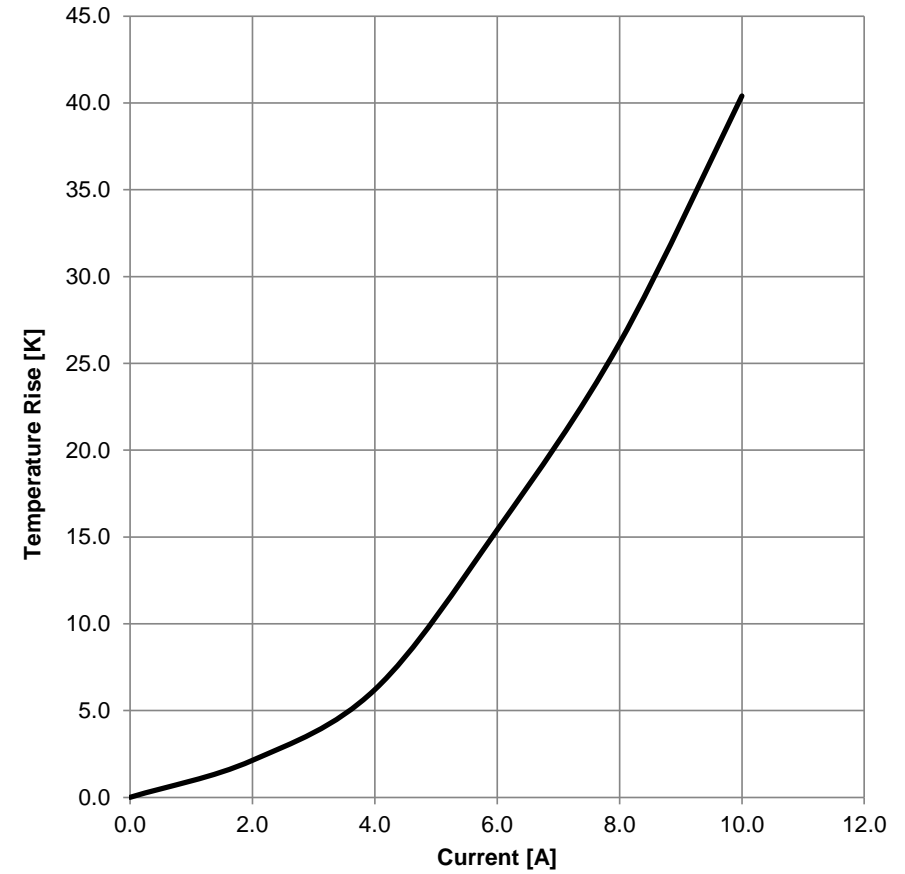

Typical Temperature Rise vs. Current Characteristics:



General:

If the product is potted in customer applications, the potting material might shrink during and after hardening. After the potting material is cured, the core, wire and termination of the product have to be checked if any reduced electrical or mechanical functions or destructions have occurred.

Cleaning agents that are used to clean the customer application might damage or change the characteristics of the component, body, pins or termination.



Direct mechanical impact to the product shall be prevented as the ferrite material of the core could flake or in the worst case it could break.

Product specific:

Follow all instructions mentioned in the data sheet, especially:

- The soldering profile has to be complied with according to the technical wave soldering specification, otherwise this will void the warranty.
- Reflow soldering is not applicable. Wave soldering is recommended.
- All products shall be used before the end of the period of 12 months based on the product date code, if not a 100% solderability can't be ensured.
- Violation of the technical product specifications such as exceeding the nominal rated current will void the warranty.
- Due to heavy weight of the component, strong forces and high accelerations might have the effect to damage the electrical connection or to harm the circuit board and will void the warranty.


