








Differential Mode

After the potting material is cured, the core, wire and termination of the product have to be checked if any reduced electrical or mechanical functions or destructions have occurred.

- •Using a brush during the cleaning process could break the wire due to the small diameter with the consequence of open circuits. We highly recommend not using a brush during the PCB cleaning process.
