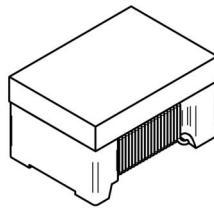

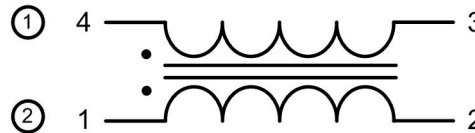

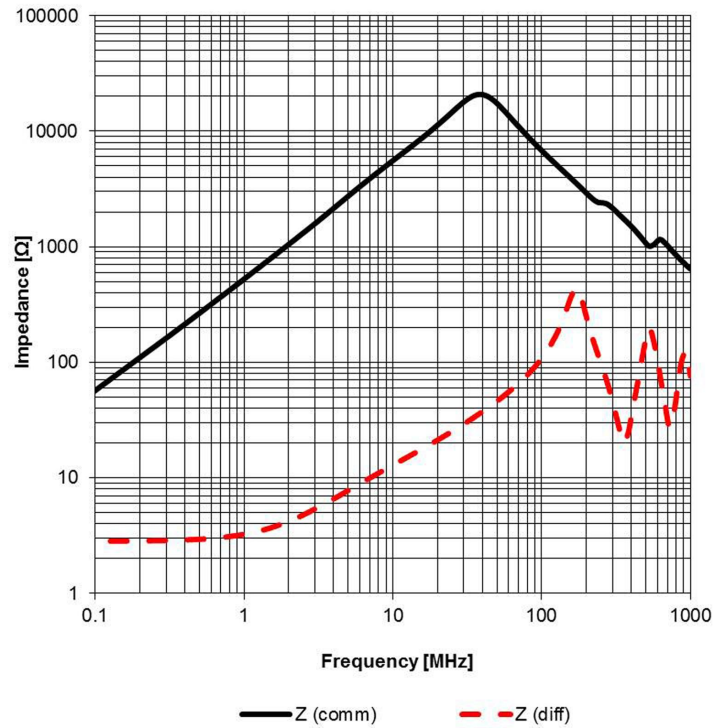



Product specific:
